APPROVAL OF AGENDA

Supervisor Wickham looked for a motion to approve the agenda for tonight's meeting. The approval was motioned by Councilman Malyj and seconded by Councilman Orbaker. Motion carried. Supervisor Wickham requested to eliminate the Town of Geneva Water Rate Letter from the agenda and had two additions to the communications to add. Councilman Keeney made a motion to amend the agenda and the motion was seconded by Councilman Orbaker.

PRIVILEGE OF THE FLOOR

Privilege of the Floor was offered, and Town Resident Bill Roberts wished to add something. He inquired about the buildings at the transfer station and wondered if they were town-owned or owned by Casella and who is responsible for maintaining them. His reason for asking is that there are a lot of brush and trees growing up against the side. He also added that there is a door and a piece of siding that blew off of a building there and is laying a long way away from the building. His concern is seeing a building destroyed due to lack of maintenance. Supervisor Wickham appreciated Mr. Roberts attending the meeting and stating his concerns and said that he would have a conversation with Mr. Sanders and Mr. Jones to determine who is responsible for maintaining that building to get it cleaned up.

Supervisor Wickham looked for a motion to approve the June 18th regular meeting minutes. The motion was made by Councilman Orbaker and Seconded by Councilman Malyj.

DEPARTMENT REPORTS

CASELLA: Mr. Jones was in attendance. He stated that construction was right on schedule and they're still shooting for the end of October or November. He explained that the weather provides challenges everyday but that everything is going as smoothly as it can.

HIGWHAY: Councilman Orbaker commended the Highway Department for getting so much work done and all working together well. They've been doing a great job.

TOWN CLERK: Supervisor Wickham explained that the towns are responsible to cover the dog control officer and dog facility and have been. The County has rationed that cost out to each town by how many dogs they have active. They're looking to change that and switch the cost to how many residents each town has. Councilman Malyj inquired about the number of renewals on Clerk Eagley's report. He thought it seemed a little low for a whole month. Clerk Eagley explained that the numbers vary monthly and in addition to that some people don't renew their dog licenses on time, which makes the number lower.

Supervisor Wickham looked for a motion to accept the Supervisor, Town Clerk, and CEO Financial Reports. A motion was made by Councilman Keeney and Seconded by Councilman Malyj.

PRIVILEGE OF THE FLOOR

Privilege of the Floor was offered, and Mr. Townley added that he would like to see the transfer station cleaned up a bit better. He said there is often junk and nails in front of the dumpsters. He's heard other neighbors speak about it. He acknowledges that they wouldn't be able to get the entire parking lot spotless. He recommended the possibility of leaving a shovel and broom out there so that maybe individuals would clean up after themselves. He wished people would look after they're own and other cars by cleaning up after themselves.

Mr. Roberts added that it was nice to see the room so full. Adding that when he was on the Town Board in the 1960's, there were two councilmen, two justices, the supervisor, the Town Clerk and the Highway Superintendent were the only ones that attended the meetings. He said rarely was there any others involved in the meeting and that most of the time it was just those seven people.

Supervisor Wickham looked for anyone else that wished to speak. Highway Superintendent Lawson added that Kristie at the Transfer Station is always outside cleaning up and wanted to give her credit for that.
